We will have a 2nd clinic for the vaccine on February 5, 2021 and then a final clinic for the booster on March 5, 2021. As always, we are working hard to keep everyone in our community safe and we will continue to practice the enhanced safety precautions that are known to prevent the spread of COVID-19, such as only essential personnel are allowed inside the facility and we screen them for signs and symptoms of illness prior to entering.
